- You must include 3 color slides or photos with application even if you have exhibited in the past.
- Upon your arrival on Saturday, September 16, you will receive information regarding parking, booth assignments, tax collections, etc.

RULES OF THE SHOW

- Work shown must be exhibitors own. No food items intended for on site consumption, commercial displays, or "kit" items will be allowed.
- Exhibitors must furnish their own tables, canopies, chairs, easels, and drop cloths. Tables must be cloth covered.
- All items sold must exhibit a ***minimum of 50% of an identifiable talent or design skill***. A roving anonymous committee will be appointed to verify. Those not in compliance will be required to leave the show.
- Exhibitors must assume responsibility for collecting, tabulating, and reporting MS Sales Tax. If you have no MS Sales Tax number, we offer special assistance for your report. **IT IS YOUR RESPONSIBILITY TO HAVE YOUR REPORT COMPLETE BY 3:00 PM SUNDAY AND TURNED IN TO SHOW PERSONNEL, EVEN IF YOU DO NOT HAVE A TAX NUMBER!** Show personnel will collect at your booth.
- Only TWO Categories will be allowed per booth. One craft category equals one numerical listing.
- Three color slides or pictures of your work must be submitted with your application. They will not be returned.
- REQUESTS FOR "SAME SPACE AS LAST YEAR" WILL BE CONSIDERED BUT NOT GUARANTEED .
- Setup shall be from 7:00 AM until 9:00 AM on Saturday, September 16, during which time volunteers will furnish free coffee & baked goods. **PLEASE DO NOT ARRIVE EARLY – THERE WILL BE NO WORKERS PRESENT BEFORE 7:00!** Exhibitors may set up after 2PM Friday, conditions permitting.
- Exhibitions MAY NOT be dismantled or secured for the night before 5:00 PM on Saturday, or 4:00 PM on Sunday. Attendance is required on both days.
- **BE PREPARED FOR RAIN AND SUN!** Tents and/or large umbrellas are **STRONGLY RECOMMENDED**.
- Parking will not be allowed next to your booth. Your vehicle must be unloaded and parked in assigned areas by 9:00 AM Saturday & Sunday. Special arrangements must be made for exceptions.
- Failure to comply with these rules will eliminate an exhibitor from this and future shows.

We love animals, but please leave yours at home. No pets on show grounds will be allowed. **RELEASE AND ACKNOWLEDGEMENT: I hereby make application to exhibit in the Arts & Crafts Show at Diamondhead, September 16 & 17, 2017.
