

5. Period of existence shall be perpetual.



6. The purpose for which it is created, not contrary to law, including a statement of the rights and powers that are to be exercised by said corporation, which said rights and powers shall be limited to those reasonably necessary to accomplish the stated purpose of the association being incorporated:

The Corporation shall be a civic improvement organization devoted to the improvement of the Diamondhead development and to the operation, maintenance, management, ownership, buying, and handling of its common facilities, areas, roads, streets, country club, yacht club, recreational facilities, and guard and security service.

The Corporation shell have the right and power to establish, develouild, construct, design, maintain, manage, operate, own, buy, sell, acquire, lease, trade and deal in cases, bars, restaurants, clubs, marinas, yacht clubs, golf clubs, private streets and roads and the expurtenances thereto, common areas, recreation areas, private police, guard and security services and similar enterprises in Hancock County, guard and security services and to engage in any other business or lississippi, and elsewhere and to engage in any other business or activity which may be useful and helpful in the operation and maintenance of any of the above.

The Corporation shall have all of the rights and powers, to the extent reasonably necessary to accomplish the stated purposes of the Corporation, given to corporations under the Mississippi Business Corporation Act, any amendments thereto, and any successor act or acts.



7. This corporation shall not be required to make publication of its charter, shall issue no shares of size shall divide no dividends or profits among its members, shall make expulsion the only remedy for non-pay ment of dues, shall vest in each member the right to one vote in the election of all officers, shall me the loss of membership, by death or otherwise, the termination of all interest of such members in corporate assets, and there shall be no individual liabilities against the members for corporate debt but the entire corporate property shall be liable for the claims of creditors.
