Craft/Vendors:

We will provide a marked-off, designated space on The Club at Diamondhead driving range tee area. You will be responsible for bringing your own table(s), chairs, and pop-up tents. Electricity is not provided. No store-bought or garage sale items are allowed. Independent product distributors will not be accepted. Set up will be Saturday, October 23, beginning at 8:30 am. Booths must be set up by 10:45 am, open at 11:00 am, and remain open until 4:00 pm. Authorized vehicles only are allowed on the driving range tee area. We will have assistance available.

Food/Food Truck Vendors:

- **No beverages may be sold out of a booth/truck at any time.**
- Vendors are permitted to use quiet generators
- All food truck vendors must display a Health Permit and must email a copy of this along with the completed application.
- Set up will be Saturday, October 23, beginning at 8:30 am. Must be set up by 10:45 am, open at 11:00 am, and remain open until 4:00 pm
- Must obey all pertinent safety codes and laws, including, but not limited to, fire, safety, and parking regulations
- The Club at Diamondhead and Property Owners Association reserves the right to shut down any vendors not meeting cleanliness and food storage safety codes and laws
- Food trucks and food vendors will provide all required equipment for operations and sales
- Food trucks and food vendors A-frame signs cannot extend further than 3-feet from the facade of the booth. Food trucks and food vendors are liable for any injury or damage caused by signs
- Any food vendors that fry must do so in a food truck only. Food vendors with a pop-up tent are NOT permitted to fry
- No grease or gray water disposal is available
- No water or ice is provided
- Food trucks and food vendors are responsible for removing debris and waste at the designated location and ensuring the general cleanliness of the area

I agree to forever release and hold harmless The Club at Diamondhead and Diamondhead Property Owners Association from liability arising from accident, injury, an act of vandalism, or theft during the 2021 Club at Diamondhead & POA Fall Fest and from product liability due to the sale of merchandise during the Fest.
