2022-28 – Motion to lease/purchase a new service cart for \$408.32 for 60 months and \$1.00 buy out at the end of the lease.

GOAL OF THE PROPOSAL: To return the service cart to full service so it can provide food and drink service to the golf course.

FINANCIAL IMPACT: Not to exceed \$21,000.00

2022-31 – Motion to accept the bid of SELA construction to make repairs and repaint the Lazy Gator Building not to exceed \$75,000

GOAL OF THE PROPOSAL: Make repairs to the Lazy Gator building that are badly needed, starting in late November & completing by mid-December.

FINANCIAL IMPACT: Make repairs to the Lazy Gator building that are badly needed, starting in late November & completing by mid-December.
