Craft/Vendors:

- We will provide a designated space in The Club at Diamondhead's main parking circle. Vendors are responsible for bringing their own table(s), chairs, and pop-up tents.
- Electricity is not provided.
- No store-bought or garage-sale items are allowed.
- Products sold must be at least 50% hand-crafted.
- Set Up: Saturday, October 21, beginning at 8:30 am. Must be set up by 10:45 am, open at 11:00 am, and remain open until 4:00 pm. We will advise the vendors if late Friday afternoon set up will be allowed, closer to the event date (overnight security is not provided).
- Tent Weights: For the safety of everyone, each booth must have weights on each leg of the tent. At a minimum, 30 lb. weights are required on each leg of your tent (or more, as the weather indicates).
- Vehicles will be allowed in the show area to set up & tear down only. Vendor parking will be available.

Food Truck Vendors:

- No beverages may be sold out of a booth/truck at any time.
- Vendors are permitted to use quiet generators.
- All food truck vendors must display a Health Permit and email a copy along with the completed application.
- Set up will be Saturday, October 21, beginning at 8:30 am. Must be set up by 10:45 am, open at 11:00 am, and remain open until 4:00 pm.
- Must obey all pertinent safety codes and laws, including, but not limited to, fire, safety, and parking regulations.
- The Club at Diamondhead and Property Owners Association reserves the right to shut down any vendors not meeting cleanliness and food storage safety codes and laws.
- Food trucks will provide all required equipment for operations and sales
- Food truck A-frame signs cannot extend further than 3 feet from the facade of the booth. Food trucks are liable for any injury or damage caused by signs.
- Any food vendors that fry must do so in a food truck only.
- No grease or gray water disposal is available.
- No water or ice is provided.
- Food trucks are responsible for removing debris and waste at the designated location and ensuring the general cleanliness of the area.
