GOAL OF THE PROPOSAL: Replace complete well components, motor, control station, line modifications and pump house.

FINANCIAL IMPACT: Not to exceed \$150,000.

2023-26 – Motion to approve the 2024 Operating Budget as presented.

GOAL OF THE PROPOSAL: Establish Goals for 2024 Operations by Department.

FINANCIAL IMPACT: Since the Budget sets Goals for Operating Departments, it does not require the outlay of any funds.
